## Four Rivers Regional Practical Nursing Program TCAT-Covington

### Practical Nursing Information

#### Mission Statement

The Tennessee Colleges of Applied Technology serve as the premier suppliers of workforce development throughout the State of Tennessee. The Colleges fulfill their mission by:

#### What types of classes are available?

**Full-time Day program** – This class is 12 months in length and meets Monday through Friday, 8 a.m. to 2:30 p.m. (clinical times may vary). Our next day class begins on September 3, 2019. We are currently testing for this class. The deadline for submitting paperwork is June 12, 2019.

**Part-time Evening/Weekend program** - This class is 18 months in length and meets Monday, Tuesday, & Wednesday evenings from 5 p.m. to 9 p.m. and 8 hours on Saturday (clinical times may vary). Our next evening/weekend class will begin in October 2020.

#### What is the Application Process?

Candidates applying for admission into the Four Rivers Regional Practical Nursing Program must pass the approved PN entrance exam (listed below). Upon successful completion of this requirement, the candidate will be handed a nursing packet to be completed by a specified date. This packet explains the requirements that must be submitted in order for the candidate to be invited to orientation.

The candidate will receive a letter of invitation to orientation by e-mail if all requirements have been submitted by the designated deadline. Orientation is mandatory. Once all of the admissions requirements have been met, an Admissions Score Sheet will be used to determine your placement status regarding acceptance into the program. When score sheets are tallied, the candidates with the top 25 scores will be considered for acceptance first. The remaining candidates will be placed on a standby list and considered for selection contingent upon their ranking score and available space. All candidates will receive an official letter by e-mail in regards to whether they were selected for the program or not. Those candidates accepted in the program are responsible for contacting the college to confirm acceptance of this position or an alternate may/will be asked to fill the seat.

#### What are the approved nursing entrance exams?

We currently accept one nursing entrance exam.

**HESI** test – score of 70% on *both* the Math *and* Reading Comprehension Components  
Best scores are accepted, not necessarily latest.

**When is the approved nursing entrance exam given?**

The HESI exam cost is \$40. The HESI exam is one test with the parts all inclusive. NO partial tests will be given. You must come to the college and pay the non-refundable/non-transferable testing fee of \$40 (no checks are accepted, but cash or credit/debit cards are accepted) to reserve a testing date and time. Limited seating is available. HESI Registration will take place Monday-Friday during regularly scheduled hours. At registration, you will select the date and time for your test.

**How do I prepare for the HESI Exam?**

**The Math Component** focuses on math skills needed for health care fields, including basic addition, subtraction, multiplication, fractions, decimals, ratio and proportion, household measures, general math facts, etc.

**The Reading Comprehension Component** provides scenarios to measure reading comprehension, identifying the main idea, finding meaning of words in context, passage comprehension, making logical inferences, etc.

**The Critical Thinking Component (not scored)** is intended to provide the student and faculty with a brief “snapshot” of critical thinking ability in usual situations encountered in health care settings and has the following sub-categories: problem solving; biases and ethical dilemmas; argument analysis; and analysis of data. **The HESI is timed exam.** We will provide students with a calculator and scratch paper for the exam. **What if I have already taken an approved nursing entrance exam and Passed?**

If you have taken an approved nursing entrance exam previously at this College, We request that you come to TCAT-Covington and submit updated contact information, so that we can pull your scores and provide you with a nursing packet. If you tested at another testing center, we request that you bring an official copy of your passing scores to TCAT-Covington and complete updated contact information and receive a nursing packet.

**What date must TCAT-Covington receive my approved nursing entrance exam scores and nursing packet?**

**The deadline for our day, full-time PN class is June 12, 2019.**

**How long are nursing entrance exam scores valid for the program?**

Approved nursing entrance exam scores must be within two years of the class starting.
